Child and Family Evaluations in a Tight Economy: What are Best Practices?

Keynote Speaker: Philip Stahl, Ph.D., ABPP (Forensic)

The COAFCC Fall Conference, "Child and Family Evaluations in a Tight Economy: What are Best Practices," was held on November 30, 2012, in Denver. The two-part presentation/panel format focused on how investigations should be conducted in a tight economy and what those investigations need to include. The conference featured the presentation of Philip Stahl, Ph.D., on both child custody evaluations and work product reviews, which Dr. Stahl noted were on the rise, especially in hotly contested cases.

Dr. Stahl's morning presentation focused briefly on the current state of investigation practices and how investigations were and should be conducted. He acknowledged that everyone doing investigations is doing "more with less." Dr. Stahl outlined elements of what he believed the CFI role and process should include: making sure there is a clear Order for what the CFI is to do, the best way of getting started, how to try to avoid harm, the importance of data gathering, and the critical point of writing the report.

The second half of the morning session focused on how he approaches critiquing both evaluations and evaluation reports. Dr. Stahl emphasized that for him the "process" used by the evaluator is what is most important. He listed the following as important elements that he looks for:

- Is there evidence of adequate informed consent?
- Did the evaluator use forms for data collection?
- Was the process thorough?
- Was the evaluator qualified?
- Was it explained in a user-friendly manner for both family and court?

A Review of the 2013 COAFCC Annual Conference

On March 22, 2013, COAFCC, in conjunction with the BIDC and MDIC, hosted a joint conference that gave attendees the pleasure to hear Barbara Jo Fidler, Ph.D., and Professor Nicholas Baba, J.D., speak on *Children Who Resist Post-Separation Contact with a Parent: A Differential Approach for Legal and Mental Health Professionals*. An added bonus was the luncheon presentation by Colene Robinson, J.D., Director of the CU Juvenile and Family Law Clinics, on the topic of *When is Your Client not your Client? Examining the Attorney-Client Relationship with Minors*.

The conference was extremely well attended and the featured speakers gave a well-organized and thoughtful presentation on the subject of how to analyze a situation where a child is resisting contact with a parent after separation. The first issue is to assess the type and severity of the strained parent-child relationship. They postulated that rejection can range between affinity (mild), alignment and justified/realistic estrangement (moderate), unjustified/alienated (severe). Only when that work is completed can the course of legal and client intervention be determined. They warned, of course, that favored parent's attitude toward the child's relationship with the other parent and their views about therapy for the child and family can greatly affect the eventual outcome. Some questions that they felt important were: What is the favored parent's attitude toward the child's right to decide? What is the role of the family court system in these cases? When is it time to give up? In case you missed it Barbara Fidler, Nicholas Bala, and Michael Saini have co-authored the book *Children Who Resist Post-Separation Parental Contact*. (2012)

During the lunch hour, Ms. Robinson discussed confidentiality and the client/lawyer privilege in relation to both a GAL (Guardian *ad litem*) and a CLR (child legal representative) in the light of the Colorado Supreme Court's decision in *People v. Garbriesheski*, 262 P.3d 653 (Colo. 2011). Ms. Robinson's conclusion was that essentially, there is no client/lawyer privilege for children and their appointed counsel within the family court system. Additionally, GAL's are not mandatory reporters. The presentation simply added to the vast amount of information that was offered at the conference.

CFI Applications and Renewal Timelines – 2013

RENEWAL affidavits (for current CFIs) will be available online April 1, 2013. Renewal affidavits will only be accepted from April 1, 2013, through 5:00 p.m. on June 1, 2013. Affidavits received after that time will not be considered. Failure to submit a renewal affidavit will result in removal from the statewide and district eligibility rosters effective June 30, 2013.

The Affidavit of Mandatory Consent and Disclosure for Eligibility of Appointment as a Child and Family Investigator and placement on the Statewide Eligibility Roster is now closed for 2013 new applicants.

Some districts conduct a local screening process. Each court has the discretion to qualify the names on the statewide eligibility list locally. Some of these districts may request additional information to aid in this process. Follow up with the districts that you have been approved to serve in and determine if the district is requiring additional information.

BOARD OF DIRECTORS VOTES TO DONATE TO AFCC CONFERENCE SCHOLARSHIP FUND

The Board of Directors of the COAFCC voted to donate \$500 to the AFCC Scholarship Fund for the upcoming 50th Annual Conference of the AFCC to be held in Los Angeles, California, beginning on May 29, 2013. The program allows people to attend AFCC conferences who might otherwise not be able to afford it. This year, AFCC will be offering more than 66 scholarships and 9 travel stipends (7 at \$500 and 2 at \$1000) to the conference. The Board's action was in response to a plea from the organization for additional funds for the fund.

It is important to note that this is not the same program as the matching scholarship program. The AFCC Resource Development Committee is charged with the development and growth of AFCC in part through the AFCC Scholarship Fund with increasing its capacity to help professionals who work with families in conflict. MEET OUR NEW COAFCC BOARD MEMBER

Jennifer Moné, Ph.D. is a Licensed Marriage and Family Therapist and runs her own private practice in Denver. Upon graduating from the University of Notre Dame, she completed a year of volunteer work through the AmeriCorps national service program, where she assisted families affected by crime and abuse. She moved to Colorado for graduate school at Colorado State University, where her research specifically focused on divorce and high conflict families. She was honored to present her dissertation research, entitled "Narratives on divorce and interparental conflict: study findings and ethical considerations for research" at the 2010 AFCC national conference. Dr. Moné works with couples and families using a systemic, strength-based, brief therapy model. Her clinical specialties include assisting families who have experienced divorce, helping couples dealing fertility challenges, strengthening couples' relationships, helping clients manage and cope with grief and loss, and assisting individuals through normative life transitions. She is also an EMDR practitioner (EMDR is a therapeutic approach aimed at reducing the intensity of traumatic events and the thoughts and feelings associated with them), which comes in useful with the trauma children can experience when pulled in loyalty conflicts between their warring parents.
